# Seeking Committee Help - Points and Membership

I have chaired this committee for the past 24 years. I need to relinquish this position but in order to do this I am seeking a volunteer whom I can train to take over this committee starting this year. I have updated the software that I use for this job and will make it available to NATRC Region 1 together with a laptop on which it is installed for a nominal charge to the Region. As long as I am able, I will support this software so that it can be kept up to date as rule changes are introduced or until such time as my replacement becomes well versed in the software.

Here is a summary of the responsibilities of this committee.

1. Keep the membership list up to date. National sends this list once a month.
2. Enter and verify all of the ride results. You may need to remind the National office to send them. If you find discrepancies in the reports, you will have to bring them to the attention of the National Office.
3. Make up and send the roster every year in the April/May time frame. I will

provide a framework for this task probably using Microsoft Word.

4. Print mailing labels for Ride Managers, Roster mailing and other Board needs as requested. I will provide instructions on how to do this using Microsoft Word.
5. Provide email lists to Ride Managers as requested in plain text files.
6. Compute the year end results and pass them for verification to the Board in plain text files.
7. Send year end results to the Leadline editor for publishing in plain text files.
8. Send out E-Blasts as requested by the Board or committee chairs.
9. Retain all past years results by year for future reference (this requires frequent usage). My software provides an easy way to do this.
10. Backup the database files frequently so data cannot be lost. This can be done onto a thumb drive. Note that the laptop also has a DVD writer in it so it could be done to a DVD or CD. I can

develop a backup script to assist in this function.

Note that all of the software is freely available and will run on Macs as well as Windows PC's. I may have to help setup the Mac if that is what the user has but remember that a Windows 10 laptop with all of the data will be available.

If no one volunteers to take over this position then Region 1 will no longer have its own Points & Membership chair and will have to rely entirely on National. Ride Managers will have to obtain their own membership lists in order to mail out ride entries and will have to create their own labels. E-blasts and emailed ride entries will disappear. This is an important position and needs a dedicated person to take it over.

# Region 1 Year End Awards Change

Throughout my entire involvement with NATRC (since 1984), Region 1 (R1) has required the completion of two R1 rides to be eligible for year-end horse or horsemanship awards. The R1 Board of Directors (BOD) at their 2016 Convention meeting decided that, beginning this year, the criteria would be changed to completion of three R1 rides to qualify.

Before the regions became joined at the hip with National through the annual dues payment (2001), one could join their Region or National or both by paying the appropriate dues to the appropriate organizations. Each had their own criteria and set of year-end awards. National has always required completion of three rides to qualify, and R1 has required two. When we say "ride" in this context, we mean physical events, not that a 1-day ride counts as 1/2 ride and a 2-day ride counts as 1 ride, etc. Originally, National year-end awards were basically just for Open Divi-

sion (except for horse and rider mileage types of things), while R1 handed out awards for all divisions, and out-of-region rides did not count for R1 awards.

It has caused some complications for National in calculating R1 team award winners since our ride criteria were different from theirs. Thus the R1 BOD thought it would be appropriate to make our criteria the same as National's (as well as all the other regions') and avoid this confusion.

Another reason considered for the change was how few R1 rides we currently have. Back in the day, R1 had as many as 10 or 12 rides in a season. They also were heavily attended, sometimes with over a hundred riders, with all divisions having overfull classes (except for Open Junior). In those days no one ever got a year-end award with just two or three rides under their belt. Requiring three rides reflects more of a commitment to earn a year-end award.

## Good-By, Ralph Dever

Ralph and Betty Dever were a familiar site at R1 rides for many years – Ralph riding his young Arabs with his quiet way, Betty timing riders out and in. I remember judging a ride at Folsom Lake; it was HOT, there were other trail users, and a lot of our ribbons were taken down at critical intersections. Many riders hustled to make time, but Ralph came in about 2 minutes over max time; he said it just wasn't the best thing for his young horse to push too much. That was Ralph.

The Devers owned Honey Bee Arabians in Elk Grove. Ralph's stallion, Raskela, won the Haggin Cup at the Tevis in 1968.

Born on January 13, 1925, Ralph passed away on March 6, 2016, about 3 years after Betty. They still warm our hearts.

### 4-H Junior Rider Year End High Point Award

Are you a 4-H member? Know someone who is? Encourage your friends to do competitive trail rides. They and you can compete against each other to win NATRC's 4-H Junior Rider Year-End High Point Award.

To be eligible is simple. Just compete in any division, nominate yourself, and prove that you are a 4-H member! Here are the specifics.

- The award goes to the high point horse and high point rider **regardless** of the rider's division.
- Your self-nomination must occur before the end of the ride year, which is the second Sunday in November. (For 2016, that will be November 13<sup>th</sup>.)
- You must (1) be an NATRC member, (2) send an email to Laurie DiNatale ([natrc@natrc.org](mailto:natrc@natrc.org)) stating that you are a 4-H member, and (3) have your 4-H leader also send Laurie an email verifying that you are a 4-H member.

Additionally, in a number of states (Colorado is one example), 4-H now recognizes competitive trail as an activity that qualifies as a 4-H member's project. How cool is that?!

## Getting Hurt by Gentle Horses

If you're alive, at some time in your life you will most likely get hurt. If you interact with horses consistently you are not only likely to get hurt, you are choosing to participate in an activity that can be life threatening. This is also true with skiing and many other fun activities. However with every activity other than horses, you will never be injured because your "equipment" spooked. If we eliminate playing Frisbee with our dog, horses are the only animals we partner with in an athletic event. The unfortunate reality is that most humans are accidentally injured interacting with gentle horses they love. The most common cause of horse related injuries is a combination of three things—lack of knowledge, lack of communication skills, and treating a horse like a big pet.

### Lack of Knowledge

In the early years of my journey with horses I was extremely lucky to survive serious injury in spite of my beginners lack of knowledge. Not knowing how or where to stand around horses caused me, on more than one occasion, to have my foot stepped on. A more serious example occurred with me showing off to a friend what I thought was the correct way to stand at an open stall door and get a horse to turn and face me. Not knowing the size of a horse's natural physical comfort zone, as I demonstrated my "skill", the horse kicked out with his two hind feet...both with shoes. One caught me on my left elbow the other in the most humiliating location a man can be kicked. I was lifted into the air and thrown five feet

out into the aisle. Thankfully, I completely healed and recovered. In retrospect, I had a dangerous lack of knowledge. I should have asked more questions, been more careful, and never made assumptions.

### Lack of Communication

My early lack of knowing how to naturally communicate with horses also resulted in my share of dangerous misunderstandings. When I was young and first starting out, much of my equine knowledge had come from watching television. During one trail ride I decided to ask my horse to canter. I took my long western reins, and just like in the movies, I spanked his butt. Not like in the movies, he bucked me off (communicating his desire for me to leave) and in turn, the hard dirt trail spanked my butt.

### Treating a Horse like a Big Pet

When I first fell in love with horses, like most people, it was almost impossible for me to be close and not touch them. I wanted to rub, hug, and pet them like big teddy bears. I didn't know that horses naturally bite each other as a means of communicating their dominance. Since they're all similar in weight (approximately 1,000 lbs) and strength, their bites and kicks usually don't cause serious injury to each other. With humans however it can be dangerous. For a while I would let them rub their heads on me, lick me, or nibble my shirt just like a big puppy. That was up until one bite down on my thumb and bit my arm so hard he drew blood. As with lack of knowledge and communication, touching and or treating a horse like a big pet is a common set-up for injuries, sometimes very serious ones.

Natural Horsemanship teaches us what is natural for the horse—how the horse experiences the world and responds to it. If I can communicate to him in his language, if I can understand how he sees, thinks and feels, then as the late Tom Dorrance used to say, I can "offer him the best deal possible". I can help him if he gets frightened, frustrated or willful. I can reassure and allow him to keep his dignity, earning his trust and his respect. I can become his leader because he wants me to be his leader.

This is why groundwork is so important. It replicates how horses communicate naturally with each other. It's how they establish who will be the leader.

Natural Horsemanship is about creating a relationship based on communicating with my horse not just physically but mentally and emotionally as well. If I expect my horse to let me ride him I must be in control in order for both of us to stay safe. Then if he's happy and goes too fast, I can speak to him physically to help him slow down. If he's afraid I can communicate with him emotionally to help him relax. If he's disrespectful I can communicate with him mentally to help him have a better attitude.

### CHOOSING THE RIGHT BIT

#### A Bit Of Knowledge

When my horse gets afraid and spooks I get anxious.

When I get anxious, I make my horse anxious.

When my spooky horse gets anxious everything becomes more dangerous.

Horses are only afraid of one thing—being eaten by predator animals.

There is nothing that can eat my horse where he lives or where we ride.

With this knowledge I never have to be afraid when my horse spooks.

With this knowledge I can stay relaxed and always reassure him.

He will relax; reaffirm his trust in me as his brave leader.

I have helped both of us from getting hurt.

#### A Bit Of Communication

When my horse is overcome with fear he will run.

To survive he will use the instinctual/"right side" of his brain which releases adrenaline.

While in this state, he cannot think nor can I communicate with him.

Physically pulling harder on the bit will cause him pain.

The pain will only confirm to him that he's still not safe. He'll run faster.

To communicate I need to do something that will cause him to use the thinking/"left side" of his brain in order to respond to me.

For a horse to cross over one hind leg in front of the other hind leg he needs to use the thinking/left side of his brain. This is called "disengagement of his hindquarters".

Getting him to disengage his hindquarters will cause his brain to switch from his fear driven/out of control right side to his thinking/ responsive left side.

The release of survival adrenaline from his right side will subside as will his fear. He will begin to calm down. His focus and attention will shift back to me. I'll pet and reassure him. We are both safe.

### A Bit Of Boundaries

All good relationships have good boundaries.

Humans and horses both have physical boundaries called comfort zones.

Entering one's comfort zone and being accepted with total safety requires love, trust and respect.

If I allow my horse close to me and treat him like a big pet, he'll treat me like a friendly horse.

Horses always play dominance games with each other to establish a pecking order (who's the leader).

Most horses are about 7ft. long, 5ft. high and weigh 1000 pounds or more.

They bite, bump, kick, swing their heads, and push each other around.

The horse that moves the other horse away first is the winner and becomes the leader.

Being of equal size allows them to physically interact this way and not get seriously hurt.

Being a human of unequal size and interacting with my horse like a pet, I can get seriously hurt.

Before I allow my horse into my personal space, appropriate physical intimacy rules must be established.

I must teach him and he must learn that he can only enter my space when invited. He must physically respect me and never treat me like another horse.


These are only 3 of many Natural Horsemanship Bits. But these 3 Bits will help create gentle horses that are truly safe and gentle for people.

## National Board Meeting Report, Feb. 2016

As everyone knows, membership is down in our organization across the nation. The board felt that offering a free membership to first time members might encourage people to join and try a ride or two. So the word needs to go out to as many people and as many places as we can think of – and that starts with our current members. Tell people you work or ride with, hang flyers or membership applications in tack and feed stores. Have talks at horse clubs, get the word out.

And to retain those new members we need to make them feel welcome in our sport and valuable as individuals. Our National president Kim Cowart suggested each region establish a Mentor/Outreach committee to put on clinics, one-on-ones and talks to groups. We're doing some of that here in our region but we need to do more. He also discussed the need for professionalism and respect toward all participants- new and not so new.

The National organization now has full ownership of the RMS (Ride Management System) and is looking into making changes to upgrade it along with making the whole process easier to use. You may already have seen a few changes but If you have thoughts or concerns on the system, we need to hear from you.

NATRC now has a YouTube channel, so look for videos on "how to" coming soon.

Finally new rule change proposals: (Changes are underlined)  
Section 1a 1(5) Supporting Membership – Any person 18 years of age or over. Not eligible for individual ride awards unless

the non-member rider fees are paid at the ride. Not eligible for year end and mileage awards unless Adult membership fee is paid before the end of the ride year.

Rationale: Older riders who quit competing can easily be lost to NATRC membership. Other members who have joined, even for a year or two, and are not competing may not renew for other reasons, economic, family changes, horse issues, etc. A less expensive membership could encourage them to remain. Suggest \$40.00 for supporting membership. Note: No monies should be returned to the regions for the supporting memberships. No loss would be incurred by NATRC.

### #3 Hoof / Leg protection

#### SECTION 5 – E. Hoof Protection/ Leg Protection

1. There are no shoeing restrictions.  
 2. All types of hoof boots that provide sole protection are allowed. However, any attached strap, keeper, gaiter or accessory must not extend above the pastern. Socks and wraps under hoof boots or any of their parts are allowed if they do not extend above the pastern. The judges may request to observe the area covered by the attached strap, keeper, gaiter, or accessory.

3. (Move from 5 F 3) Protective devices, such as bell boots or wraps, are not permissible on the legs of horses except for hoof sole protections as allowed under Section 5.E.2. The leg is defined as all structures above and including the coronet.

Protective devices, such as bell boots, splint boot or leg wraps are not permissible on the legs of horses except as part of hoof sole protection as allowed in 5 E 2. . The leg is defined as all structures above and including the coronet.

Rationale: (1) Socks and wraps under hoof boots or their acces-

ries have been considered leg protection. Is it more appropriate to consider these as hoof boot protection? (2) Moving #3 from the current section (5 F) on tack to the rules on shoeing and hoof protection makes more sense.

### #3 Junior Competitors

#### 3. Junior

- Age 8 through 17. The rider must be 8 years old to enter competition; thereafter the age of a junior shall be determined by whatever their age is as of the beginning of the ride year and this age shall continue throughout that ride year. Juniors under the age of 16 must be accompanied by an adult (18 years or over) on the trail unless the junior rider has at least 300 competition miles or has completed a minimum of 10 rides of any ride type.
- Juniors may not compete in Novice Heavyweight, Novice Lightweight, or Senior classes. Juniors may compete in Open Heavyweight or Open Lightweight classes if weight requirements are met.
- b. Juniors (See Section 4 B3a) may not ride stallions.
- c. No weight requirements apply if competing in Junior Class.

Rationale: Multiple families have indicated this has been a large factor in them either not joining NATRC, or stepping away from NATRC and going to other distance riding organizations so that their children could compete with them. This proposal would reduce those losses in the future.

## Secretary's Report:

The minutes of the meeting held 09 September 2015 were submitted for review. Phil moved to approve the minutes with one correction (under year-end awards, write-up for Tammy Brown by Donna, NOT Angie), Linda seconded; all agreed. Resumes for upcoming election of two (2) board members have been received; they include Stephanie Swain and Donna Stidolph. Ballots will be prepared for the election to be held at the 2016 National Convention.


