



Hi All,

I have to say, I'm just amazed at my power: in the last issue of Leadline I asked our members to reach out and talk to people about our Leisure Division. And, wow, did that ever happen - we've had great turn-outs for the LeD! Ha! Seriously, thanks to all of you who marketed for us – but particularly Sheila who is running the CTR discussion group on Facebook and appears to be an expert at firing people up TO RIDE! (If you haven't dropped in to the discussion group, check it out – there's a link to it on the R1 website.)

So. We're getting lots of participation, which is wonderful. We've had returnees from a zillion years ago, we've had moms whose kids ride NATRC, we've had friends of people who ride NATRC, we've had riders who want a transition step to AERC, and we've had ones who are just looking for new adventures – definitely our tribe. And since our Ride Managers have stepped up and put on LeD rides at all our "traditional" sites, the participants have had a chance to experience pretty much all aspects of our sport, with the exception of miles.

What's even more wonderful is the quality of those participants. I haven't had a chance to ride with any of them, but I've seen them in and around camp, hanging out and riding. Their camps have looked safe and organized, and their horses seem to be well-conditioned and well behaved. More interestingly, the LeD riders I've run into have been curious about my camp and my equipment and haven't felt the need to explain to me why I'm wrong – I don't think I heard a single "Well, but . . ." at Eel River. They've shown up early to check out how we set up ride camp, they've come down to watch our vetting in, they've attended our ride meetings to find out what to expect, etc. They are truly using this as an opportunity to learn, educating themselves not only to succeed in a competitive trail venue, but to incorporate those skills into everyday riding and horse camping.

I don't know how many of them will turn out to be return riders or how many of them will elect to move to a longer mileage division – but I'm pretty sure that at least a few of them will opt to ride in our other divisions and they've been preparing. So all you Old Timers – look out! The LeDs are coming!

**4-H Year End High Point Award**

Are you a 4-H member? Know someone who is? Encourage your friends to do competitive trail rides. They and you can compete against each other to win NATRC's 4-H Year-End High Point Award.

To be eligible is simple. Just compete in any division, nominate yourself, and prove that you are a 4-H member! Here are the specifics:


- 1) The award goes to the high point horse and rider team **regardless** of the division.
- 2) Your self-nomination must occur before the end of the ride year which is the second Sunday in November. (For 2019, that will be November 10<sup>th</sup>).
- 3) You must: (a) be an NATRC competing member, (b) contact Sarah Rinne at [natrc@natrc.org](mailto:natrc@natrc.org) to nominate yourself, and (c) have your 4-H leader contact Sarah to verify that you are a 4-H member.

Additionally, in a number of states (Colorado is one example), 4-H now recognizes competitive trail as an activity that qualifies as a 4-H member's project. How cool is that? So Susan Travers said I could probably tell this story better than she...I will try. This pic is at the 2nd P&R, after we have come up an extremely steep (23%) 1/2 mile grade and done a loop on fire roads. Now all of us have to go back DOWN....yikes. I know this trail now, helped open and mark it for the ride. It's called Nancy's Bitch Of A Trail for a reason! Note here while Susan is mounting that she does not use a crupper (many people don't, not required and saddles fit differently). Susan is about to find out why so many trail riders DO use a crupper. She mentioned that she knew this might be a problem, so we took the hill verrrrrry sloooowwwlyyyyy. I'm in front of her, we get juuuussstt allmostt about 100 feet from the bottom of the very worst of it, and I hear behind me a kind of...squeak, "waah/irk".



Look back and Susan and her mare are stopped on the hill, head down, saddle up on her withers, and Susan slowly tilts forward and tries to grab mane, rolls very gracefully over her mare's shoulders and onto the trail...and keeps rolling! Remember, steep grade? It seems Susan had long ago learned to tuck and roll! Not a scratch on her, she gets up, her mare is still standing, just there gazing at her like she does this every day, with the saddle still on her neck. What a great horse!!

## YOU want to do WHAT??

### ***NATRC Region 1 is searching for a few good men and women.***

Every volunteer counts! Together we can offer more rides in new locations and resurrect some of the older ride locations.

Every ride manager, secretary, trail master, P&R worker, timer, and Rules Interpreter was once a "First Timer". Is it a tad scary?--yup. But once you accept the challenge and do it, the rewards of doing something for the organization and your fellow riders is amazing! It's a great sense of accomplishment and you learn A LOT.

Are you alone? NO! Experienced people will be there to help and guide you along the way. Your ideas, your way of accomplishing things, may be different from prior volunteers, but new ideas keep the sport fresh and add interesting elements to the rides.

Rides can be put on by individuals, clubs, or just a group of friends interested in the sport. You do NOT have to be a member. You may be an experienced competitor OR NOT. Numerous rides across the US are put on by people who are not competitors, and some do not even ride. But they all share a love of horses, the outdoors, and using trails to help preserve them.

If you are worried about finances, there are resources available to help. NATRC Region 1 offers a grant of \$500 for a ride that includes all divisions, and \$300 for a clinic or a stand-alone Leisure Division ride. NATRC national offers a Ride Management Support Fund (RMSF) which can provide up to \$1000 towards ride startup expenses. Both the Region 1 grant and the RMSF are great resources to utilize, especially for a new ride manager or a new ride location. At the end of the ride, a financial report is submitted to whichever fund you applied for, and if the ride made money you pay it back to support future ride managers. If the ride lost money, then the "loan is absolved" and you do not have to pay it back. This type of support exists to encourage ride managers to accept the challenge without undue financial worries.

This year Region 1 has received a special offer of a \$500 donation towards any NEW ride put on for 2020. This donation is free and clear and does not need to be paid back after the ride. Our benefactor wanted to encourage new rides and graciously offered this incentive. I encourage anyone thinking of putting on a ride in 2020 to take advantage of this generous offer. Let's not let this generosity go to waste! The Region 1 grant application is available on the Region 1 website [www.natrcregion1.org](http://www.natrcregion1.org) and the RMSF is on line on [www.natrc.org](http://www.natrc.org)

Many thanks are due to the tireless workers who put on and volunteer at rides year after year. But they need an occasional break. In any organization there exists a core group of people who volunteer the most hours. Our core group needs some new folks to help out so that the rides will continue and we will all be able to enjoy them.

Yes, it's fun to ride, but each ride requires many volunteers and a lot of work to put on. So, consider putting on a ride, or at least volunteering at a ride each year to help out the management team. Don't be shy, your help is always appreciated!

## YOU want to do WHAT?? continued

### 1. Ride Chairman

Selects ride location, applies for ride sanction (form is on line), applies for ride insurance (Equisure application is on line), secures permission from land owners, BLM, state park management, etc, prepares an estimated budget, secures judges, secures volunteer personnel, sends 6-week ride report to the sanction chair at NATRC national (form is on line), secures awards, makes sure other volunteers have what they need, and becomes familiar with the rule book. Some of these duties may be assigned to people assisting ride management or shared with a ride secretary. You don't have to do it all yourself, you may delegate, but your responsibility is to follow up and see to it that it all gets done. The ride chairman introduces judges and other key personnel at ride briefings and does the ride briefing, or may assign to trail master.

### 2. Ride Secretary

Can share some duties with the Ride Chair. After ride is sanctioned, uploads entries into RMS (there are folks who can teach you and help you with RMS), arranges for Publicity (Eblasts, flyers), keeps accurate treasury records, copies forms for the timers, weighmaster, weight cards, P&R cards, awards sheets, Rules Interpreter instructions, and accident sheets. *Most forms are available online at [www.natrc.org](http://www.natrc.org).* Makes up rider packets, assigns bib numbers, packs office supplies, and takes to the ride. Runs registration in camp, creates and distributes updated rider lists. Prepares and sends in end of ride reports. Helps with awards.

### 3. P&R Captain

Familiarizes self with the procedures and the trails.

Knows the P&R stops. Selects and trains the P&R team. Makes sure everyone has a watch with a second hand. Makes the P&R cards unless they are provided by the secretary or ride chair.

### 4. Rules Interpreter

This is the only position where NATRC membership is required. In this role one must be familiar with the current rulebook. Reviews the Rules Interpreter report form (available online). Does not comment to the judges or ride management unless a rule infraction is observed or you are asked by ride management (not the riders) to make a ruling or answer a question. You are a behind the scenes person who is seen but not often heard.

### 5. Trail Master

Locates and decides on the trail and makes the map. Is in charge of getting the trail marked prior to the day of the ride. Times the ride. Locates the P&R stops and the 2-mile point. Helps prepare the briefing information.

### 6. Judges Secretaries

Learns the parts of the horse (drawings are on the back of the horse scorecards). Studies the scorecards and the nomenclature ahead of time. Helps check the math for scoring. Writes legibly on the cards. \*\*Being a judge's secretary is a great way to learn what the judges are looking for and how they evaluate the horses- an experience I encourage everyone to try!

### 7. Ride Timers


Records exact time each rider begins her ride, and the exact time she comes in at the finish. Must have an accurate watch and a back up watch, pencils, and a hard writing surface. Must write legibly. The timer sheets will be provided by the ride secretary. Bring suntan lotion AND an umbrella- you just never know.

### 8. Point and Safety Riders.

Needs conditioned, steady horses. Must understand the trail map. Carries a small first aid kit. Must be able to pony a horse in an emergency, carry an extra halter and lead rope, and be friendly and supportive to the riders. Safety riders must be able to stay well behind the assigned division but try to keep them in sight and not interfere with their ride. The job of point riders is to ride out first, staying well ahead of the riders, to check that the trail markings are still up and haven't been moved, destroyed or eaten by critters.

### 9. Miscellaneous positions:

P&R crew, cooks, in-camp helpers, parking assistants, raffle/silent auction directors, general helpers in camp.
